Micron Signs MOU for Building Partnership with Acer Healthcare

Micron, Inc. (Head Office: Tokyo, President: Michita Sato) is pleased to announce that it has entered into a Memorandum of Understanding with Acer Healthcare Inc. (Head Office: New Taipei City, President: YH Hsu) to form a partnership to develop and expand their respective software as a medical device (SaMD) businesses.

Acer Healthcare is an affiliate of Acer Group, a global IT company, founded with a goal of improving human health and well-being through AI. Utilizing its know-how centered on artificial intelligence (AI) and big data analytics, Acer Healthcare engages in cross-domain collaboration with hospitals and healthcare-related industries, designs and develops intelligent medical products for the healthcare sector, and promotes them in international markets. In 2020, the company obtained the first ophthalmic imaging AI diagnostic software certification by the Taiwan Food and Drug Administration (TFDA).

In addition to the CRO business that supports the clinical development of pharmaceuticals and medical devices, Micron is engaged to the imaging biomarker business (development, support for obtaining approval/certificate for medical devices, manufacturing and marketing of SaMD, etc.). We aim to further develop the imaging biomarker businesses and achieve any synergistic effects with the CRO business by building a cooperative relationship with Acer Healthcare, which has advanced technological capabilities in the fields of AI and big data analysis technologies.

Since establishment, Micron has been contributing to healthcare by approaching medical imaging from both the diagnostic and therapeutic perspectives. The new project "INDICATE" (INnovative Diagnostic Imaging Capabilities Adoption To End -users delivers innovative imaging technology to your doorstep) was launched with the theme of "Bridging the gap between SaMD and diagnostic technologies". In this project, we are introducing and proposing image analysis technologies that incorporate AI and other advanced technologies. We will be a bridge between domestic and foreign companies that want to introduce SaMD in Japan, and pharmaceutical companies and medical device companies that are interested in advanced technologies. We will continue to contribute to the development of digital healthcare technologies related to medical imaging.
